Example #1: If you use 300 kWh, you will be billed \$31 plus taxes. Example #2: If you use 900 kWh, you will be billed \$31 plus taxes.

Example #3: If you use 1,400 kWh, you will be billed \$99 plus 10.0 cents for the 400 kWh in excess of

1,000 kWh for a total of \$139.00 plus taxes.
